FALL GRANTS AWARDED

The Community Foundation of Randolph County awarded over \$18,000 to county organizations in November, 2008. The following awards were approved and awarded through the Union City Community Fund:

Art Association of Randolph County - \$3,760 to assist with the costs of the 55th Annual Exhibition Art Show to be held in 2009.

Union City Baseball Boosters - \$4,000 to assist with the building of new dugouts.

United Way of Randolph County - \$808.20 to purchase a new computer for the office.

The following awards were approved and awarded through the Community Foundation Unrestricted Fund:

Huntsville Community Center - \$2,000 for the installation of a water well and pump system to supply a water source for the community center.

Community and Family Services - \$3,450 to support the Food Pantry, under-

write the cost of food and non-food items for Randolph County families.

Cancer Services of Randolph County - \$1,800 to provide seminars for cancer patients and/or caregivers.

Randolph County 4-H - \$2,250 to support a new program titled Read, Taste and Touch which is a book club for pre-school age children and their parents, with nutrition and agriculture connection.

Grant awards are possible because of the generosity of individuals and businesses. All gifts to the unrestricted fund are invested and the income used to provide grants for the county.

According to Grant Committee Chair Paula Cheesman, "We are so pleased to provide this support for Randolph County. The Foundation's strongest impact on the community is through the organizations it supports."

The Community Foundation accepts grant applications each spring and fall. Randolph County non-profit organizations are invited to contact the Foundation if they are interested in applying.

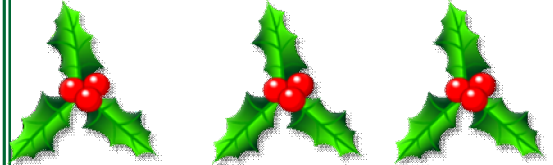

70 1/2 or older?**

In October 2008 Congress and the president agreed to extend the IRA contribution rollover for all of 2008 and 2009. Individuals 70 1/2 or older can roll over up to \$100,000 **TAX-FREE** each year from their IRA to eligible public charities. This includes any of the charitable funds held at the Community Foundation. Take a look at the list of funds on page 3 and consider a tax-free rollover from your IRA for any amount.
