CFRC Receives Record Number of Grant Applications

The Community Foundation received a record number of 17 grant applications requesting a total of \$93,400 for its Spring Grant cycle. With a total of \$31,000 available for awards to deserving applications, the Grants Committee, consisting of CFRC Board members and community representatives, deliberated carefully prior to making the final funding recommendations.

\$16,000 was available to be awarded through the Community Foundation. The organizations receiving grant awards are as follows:

- **Drug Free Randolph County—\$1,850** to assist with the costs of teens attending the Indiana Teen Institute
- **Energize-ECI, Inc.—\$200** to support development of a Regional economic development website
- **Farmland Conservation—\$2,800** to fund a more efficient and handicapped accessible entrance to the property
- **Girl Scouts of Wapahani—\$500** to support new Healthy Living initiative in Randolph County.
- **Historic Farmland—\$3,000** to assist with cost of new playground equipment for Wildcat Park
- **Monroe Central Grizzlies—\$1,000** to assist with purchase of equipment for youth football teams
- **Randolph County EDC—\$2,500** to assist with costs for "From Good to Great" project keynote speaker
- **Saratoga Baseball League—\$2,000** to fund renovations and improvements to facilities in Saratoga

- **Camp Yale—\$1,150** to assist with the creation of a Community Leadership Program to build leadership skills for Randolph County residents and future leaders
- **Community and Family—\$1,000** to assist the Winchester area Community & Churches Food Pantry (WACCFP)

What is the Community Foundation?

In the broadest sense, the Community Foundation of Randolph County, Inc. is here to make our community the very best place to live, work and to raise a family. As a non-political private organization, we are uniquely able to provide grant money for innovative projects that have a major impact on our community.

The Community Foundation's work falls into three major categories: Grantmaking, donor service and community convening.

Our most visible activity is the grants and scholarships we award each year. In 2006, the Foundation provided \$109,000 to the community in grants and scholarships. Most of these awards come from income earned from permanently endowed funds. Some of these endowed funds are unrestricted—meaning that the foundation board has the responsibility to use the income as it best determines—generally in response to applications from community organizations. Scholarships and other grants come

from funds that donors have established for certain purposes.

Helping donors to achieve their charitable objectives is also an important activity of the foundation. We work with individuals and organizations that want to create a lasting legacy for Randolph County. For as little as \$10,000, donors can create a permanent endowment fund that generates income to benefit any charitable cause they wish to support.

Because we are a non-political private organization, the foundation also can serve as a convener of organizations and individuals around a particular cause. As an organization looking out for the welfare of the entire county, we can be a safe and neutral place for people to discuss problems and potential solutions to the issues that face Randolph County.

Lilly Endowment Scholarships Awarded

The Lilly Endowment Scholarship provides full tuition for any college or university in the State of Indiana. Through 2006, the Community Foundation of Randolph County has awarded 22 Lilly Endowment Scholarships with a total value of \$1,220,736.

\$15,000 was available to be awarded through the Union City Fund. The organizations receiving Grant awards are as follows:

- **Cancer Association of Darke County—\$1,150** to assist with transportation costs, medical costs and cancer support for the surrounding area, including Indiana cancer patients.
- **Community Christmas Corporation—\$2,500** to assist with costs to expand light displays in Harter Park
- **The Randy Players—\$7,500** to assist with the cost of staging platforms and set replacement.
- **Union City Baseball—\$3,000** to assist in funding construction of a restroom facility and concession stand for the ball diamonds located south of Union City.
- **Village of Union City, Ohio—\$500** to assist with website development
