Randolph County Promise

The Community Foundation of Randolph County is excited to announce it will be partnering with retired teacher, Carol Mills, on a new educational initiative titled Randolph County Promise.

Carol has degrees from Taylor University and Ball State University. She began teaching at Union School Corporation in 1977 and retired from there in 2014. From 2014-2016, she worked as a Title I Aid at Willard Elementary School in Winchester. She returned to Union in the fall of 2016 but has since retired again.

The purpose of Promise Randolph County is to encourage elementary school students and their families to begin thinking about and planning for education beyond high school. All five school corporations in Randolph County are engaged in the program, which will be rolled out this coming school year.

Students enrolled in the program will participate in college and career discovery activities at school and take a field trip to IU East in Richmond this fall. In early 2019, the Community Foundation will assist families in opening 529 college savings accounts. The Community Foundation will even deposit the first \$25 for each student!!

Participants can earn up to \$75 in matching dollars by adding money to the account or by asking Community Champions to contribute. Be sure to visit the Promise Randolph County booth at school registration this summer to find out how you can start saving!

Union City Community Fund

Looking back at the Community Foundation's 25 year history wouldn't be possible without those who worked selflessly to make a dream become a reality. Some of those that helped make the Community Foundation such a successful and vital organization include Allen Jefferis, Ray Griffin, and James Davis of Union City. In 1999, the Community Foundation was 6 years old and hadn't really taken off yet. But, the Union City group had an idea that would change everything.

At the time, the Lilly Endowment was matching gifts made to endowed funds held at the Community Foundation 50 cents on the dollar. As luck would have it, Union City had just sold its hospital and was trying to decide how to best use the money to help the community. Jefferis, Griffin, and Davis convinced others in the community that the best option would be to take advantage of the Lilly Match by opening a fund at the Community Foundation.

It was a win-win situation. A new fund was established for the purpose of bettering the communities of Union City, Indiana and Union City, Ohio and Randolph County. The opening gift of \$420,000 earned a matching gift of \$210,000, which was deposited into the Community Enrichment Fund. The earnings from both funds are granted to Randolph County nonprofit organizations for projects that benefit the community. To date, over \$325,000 has been granted from the Union City Community Fund and over \$575,000 has been granted from the Community Enrichment Fund.

Investing the money in one large pool helped increase the earnings. Today, the Union City Community Fund has a balance of nearly \$700,000 and the Community Enrichment Fund has a balance of nearly 2 million dollars! Jefferis and Griffin are still active members of the Community Foundation Grants Committee. Davis will be going off the committee at the end of the year. "We were very happy to help get the Foundation started" Davis said of their involvement in the Foundation's success.

Spring Grants Awarded

The Community Foundation's Board of Directors approved and awarded \$30,865 to Randolph County non-profit organizations.

- **A Community Christmas Corporation—\$4000** | Funded by the Union City Community Fund to help with the cost of a building to house lighting and displays during the off season.
- **Art Association of Randolph County—\$3100** | \$850 from the James and Linda Noffsinger Fund and \$2250 from the Community Foundation Enrichment Fund to purchase outdoor play equipment for Arts Depot, compensation for artists, student workshops, permanent collection maintenance, and art purchase.
- **City of Winchester Park Board—\$2500** | Funded by the Community Foundation Enrichment Fund to hire performers and pay for sound and banners for free public concerts in Goodrich Park.
- **Community Help Center of Union City—\$3000** | Funded by the Union City Community Fund to purchase lighting and security cameras.
