# Lilly Endowment GIFT VII Match Opportunity Maximizing the Power of Giving

Triple your money! Between now and December, 2020, for every \$1 you donate to the Community Foundation's Unrestricted Funds, \$2 will be added from the Lilly Endowment Match. It is easy to impact Randolph County by tripling your money!

We are happy to announce that we have been approved to receive a matching fund grant as part of Lilly Endowment Inc.'s seventh phase of its Giving Indiana Funds for Tomorrow (GIFT) initiative. With GIFT VII, the Endowment is making up to \$125 million available to help Indiana community foundations strengthen the towns, cities and counties they serve.

The Community Foundation of Randolph County can use this matching fund grant to build our financial assets and support our charitable activities. At least two-thirds of the matching fund grant must be designated to support the growth of the Community Foundation of Randolph County's unrestricted endowments, which over time will provide flexibility to help the foundation to meet community needs through grantmaking. The Endowment will provide \$2 for every \$1 contributed to Community Foundation of Randolph County's unrestricted endowments during the matching period, October 1, 2018, through December 31, 2020.

The Community Foundation's primary unrestricted fund is the Community Enrichment Fund. In 2015-2016, during a previous Lilly Endowment initiative, several new unrestricted funds were opened including the Randolph County Heroes Fund, Wicks Employee Giving Fund, Chip & Ruth Loney Fund, James and Linda Noffsinger Fund, Thom and Janice Powers Fund, Starr Family Fund, and the Whitacre Family Charitable Trust. Two additional unrestricted funds that were recently opened are the Rural Randolph Cares Agricultural Endowment Fund and the Joel and Jane Flesher Family Endowment Fund. All of these funds will be eligible to receive the 2 to 1 match during Gift VII.

The GIFT initiative is part of Lilly Endowment's grantmaking to strengthen Indiana communities and has been a priority of the Endowment since the first phase of GIFT in 1990. The initiative's primary aim is to help Indiana community foundations develop the philanthropic capacity to identify, prioritize and address local opportunities and challenges.

It seemed like a logical fit and a way to continue supporting the Community Foundation by sharing space and personnel. and a partnership was born. "It is such a nice gesture of First Merchants

Bank to remodel this space for the two foundations," Talley said. "Finding the right space and location has not been an easy task, I am very happy to find a permanent home for The Winchester Foundation."



# 25th Anniversary Celebration

Current and past staff, board members, and donors of the Community Foundation of Randolph County gathered recently at Towne Square Community Centre in Winchester to celebrate 25 years of giving. Guests enjoyed a catered meal prepared by Chef Dugan of Reid Health and heard presentations about four different endowed funds held at the Community Foundation; The Max and Dianne Jones Memorial Music Lesson Scholarship Fund, Randolph Promise Fund, Rural Randolph Cares Agricultural

Fund, and Union City Community Fund. Guests were given 10 minutes to donate to the fund or funds of their choice. A total of \$6,440 was raised. The Community Foundation provided matching dollars totaling \$5,082.50 bringing the amount raised for the four funds to \$11,522.50.
