Nonprofits are encouraged to partner for existing program enhancement and /or new program development.

Success should be measured by the ability of program participants to receive services that provide them a picture of a better life beyond today.

## Program area examples include, but are not limited to:

### *Family Crisis Prevention*

Family Support, Financial Literacy, Parenting Enhancement

### *Women in Crisis*

Domestic Abuse, Teen Pregnancy, Divorce, Death of a Spouse

### *Education*

High School Completion, Postsecondary Education Readiness

### *Youth*

Leadership, Community-Appropriate Behavior, Life Skills

# **GRANT GUIDELINES**

## **2020 WOMEN'S FUND OF RANDOLPH COUNTY**

### **GRANT CYCLE**

- Applying organizations must have administrative offices located in Randolph County.
- Capital projects will not be considered for funding.
- No grants will be made solely to individuals and grants will not be made to organizations for the purpose of providing scholarships to individuals.
- No grants will be made specifically for sectarian religious purposes but can be made to religious organizations for general community programs.
- Applying organizations must operate without illegal discrimination on the basis of race, religion, gender, sexual orientation, age, national origin, or disability.
- The Women's Fund of Randolph County, held by the Community Foundation of Randolph County (CFRC), supports projects and programs of organizations when the projects and programs being supported have a charitable purpose and are consistent with the mission of the CFRC. Generally, the determination of whether an organization's activities are charitable or not is made by the IRS in assigning a tax-exempt status. Organizations with a 501 [c] [3] not-for-profit status are engaged in charitable activities. The Women's Fund may also make grants to non-501 [c] [3] organizations when the grant is for a charitable purpose. Make sure application includes the following: ***Incomplete application packets will not be considered for funds.***

1. Cover page (provided with the application materials) with the following information:
  - Name of Organization
  - Amount Requested
  - Contact Person, Telephone Number, and E-mail Address
  - Authorization Signature
2. Specific Project Components
3. Brief Explanation of how your program will provide solutions to unresolved community needs
4. Target Population of Organization
5. Total Project Cost
6. Agency's Total Budget for Current Fiscal Year (income and expenses)
7. Agency's 501[c] [3] determination letter (when applicable)

***Please limit grant narrative to three (3) pages including the cover page.***
