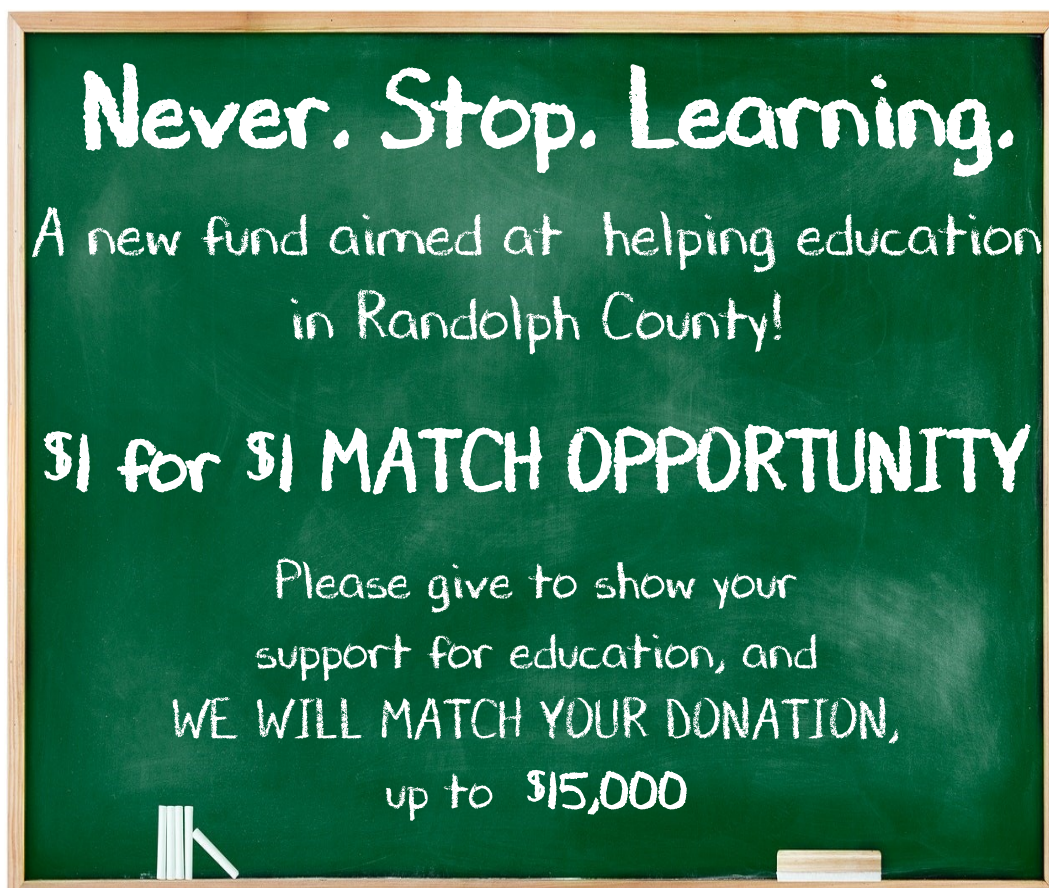

A Note from the Executive Director



How has this year looked different to you? You may have spent more time at home. You likely have greeted friends with masks. We hope you have remained healthy, but know that many of you may have experienced sickness and even the loss of family and friends.

This year has looked different for the Community Foundation and nonprofit organizations that we support. There was a sudden demand for personal protective equipment, PPE - an acronym many didn't know before March. Programs, activities, and events were canceled. The need for human services, like food and shelter, increased across the county. Financial stress has been incurred within already tight budgets, and the added expenses from all the things needed to keep volunteers safe, such as masks and sanitizer, to the cost of having to transition to online operations. No one could have predicted this future.

However, especially in 2020, we are grateful for our founders' foresight and the power of endowment that allows the Community Foundation to make a difference in Randolph County. THE CARES ACT

The philanthropy sector has long been pushing for a permanent universal tax deduction so Americans who don't itemize their taxes can get tax benefits from their charitable donations.

As part of the CARES Act, there is now such a universal deduction. A provision in that act allows any taxpayer to deduct up to the first \$300 they donate to nonprofits in 2020. The National Council of Nonprofits is currently advocating that Congress raise that dollar amount and extend it to at least 2021, since the COVID-19 recovery won't be done by December 31.

Did you know? A new report from the Johns Hopkins Center for Civil Society Studies finds that U.S. nonprofits maintained their position as the third largest employer in the U.S. economy, overtaking manufacturing by nearly 100,000 workers nation-wide in 2017, and exceeding that industry in 28 states and territories across the U.S. Indeed, the only industries employing more workers than the nonprofit sector in 2017 were retail, trade and restaurants and hotels.

NEW Online Scholarship Platform

Application period **Opened December 1, 2020** and **Closes January 15, 2021**
(Seniors graduating in 2021)

The Community Foundation of Randolph County is pleased to announce a new online scholarship application! The vendor partner is International Scholarship and Tuition Services (ISTS). ISTS customized an online scholarship application tailored to our specifications. The Community Foundation offers more than 70 scholarships and now students can complete one form that would allow them to qualify for multiple scholarships.

The Community Foundation awards scholarships to students who are high school graduates of a Randolph County school corporation: Monroe Central High School, Randolph Southern Junior/Senior High School, Union High School, Union City Junior/Senior High School, and Winchester Community High School. Scholarships are also available for students from New Castle and Mississinewa High Schools, non-traditional students who worked in the glass or mold industries, are a displaced worker from Randolph County or non-traditional students who attended Monroe Central High School.

3. Grant Award

The Community Foundation of Randolph County has received a Community Leadership Grant of **\$100,000** as part of the seventh phase of Lilly Endowment Inc.'s Giving Indiana Funds for Tomorrow (GIFT VII) initiative. With the grant, we will embark on an innovative partnership designed to empower nonprofits to focus on their mission work in order to turn the curve and collectively measure community-wide quality of life goals.

Utilizing this Community Leadership Grant, the Foundation will work with community partners to develop a holistic approach to support and strengthen nonprofit organizations, as well as support the development and measurement of community-level goals utilizing Results-Based Accountability framework.

The Community Foundation of Randolph County, Inc. encourages philanthropy, assists donors in building an enduring source of charitable assets, and exercises leadership in directing resources to enhance the quality of life for residents of Randolph County.

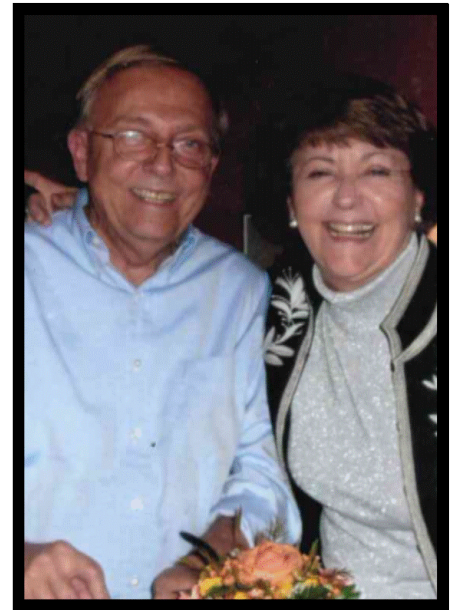

5. The Newest Randolph County Heroes!

The News-Gazette and the Community Foundation of Randolph County continue their celebration of local heroes who have made an impact on the community or have gone above and beyond expectations to serve others. This effort is the result of a community foundation program that helps recognize such people while also raising money to help others.

"We thought a really neat thing would be to create a list of Randolph County Heroes," said Community Foundation board member Cathy Stephen Miller of the ongoing program which started in 2015. "For \$1,000, anyone can nominate a person (living or deceased), organization, business, or community organization for the designation as a Randolph County Hero. The money goes into our unrestricted fund, which the board uses to do great things for Randolph County. It all has to do with making Randolph County a great place to live."

People who are designated as Randolph County Heroes will have a plaque in their honor at the foundation office, and will be featured in the News-Gazette.

The newest Randolph County Heroes are Allen and Betsy Jefferis. They were nominated by a generous donor who wishes to remain anonymous.

Betsy and Allen Jefferis have been valiant members of the Union City community more than half a century. Allen was a businessman from the time he and his bride returned from college. Betsy championed the arts as a member of the Art Association of Randolph County and, along with Allen, took an active role in the restoration of the old railroad depot which became the home of the Art Association of Randolph County in 1983. Along with others of that group of "restorers" they formed what is now the Preservation Society of Union City, IN/OH. That group then restored and repurposed the old Kirschbaum Building (now the Antiques Mall) and the old hotel and commercial buildings which became the City Museum, Community Room and the City's City Hall and Council Chamber. Always thinking of the betterment of Union City and Randolph County both Betsy and Allen have left an indelible mark on the city and the county. It was through the efforts of Allen and other businessmen that the Union City Community Fund was established from the proceeds from the sale of the old Union City Hospital. That fund, in turn, became the initial building block of the Community Foundation of Randolph County. Allen Jefferis holds the title of Director Emeritus at the Foundation which is reserved for those retiring directors who have had distinguished service and whose extraordinary contributions set them apart from their peers. Achieving the status of Director Emeritus is to be viewed as the highest honor that the Foundation may bestow upon a Foundation Board member. Betsy and Allen Jefferis are truly Randolph County Heroes!

Women's Fund 2020 Online Charity Auction and Art Contest

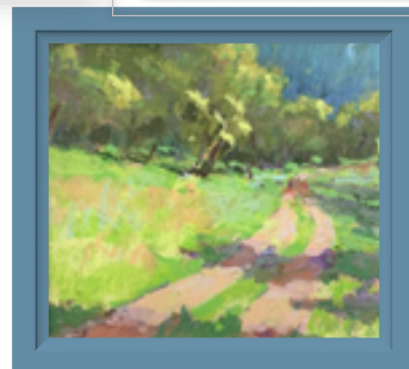

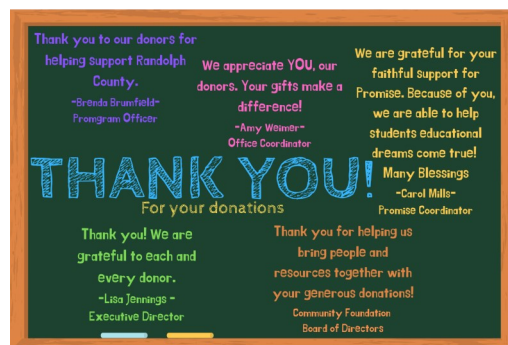
