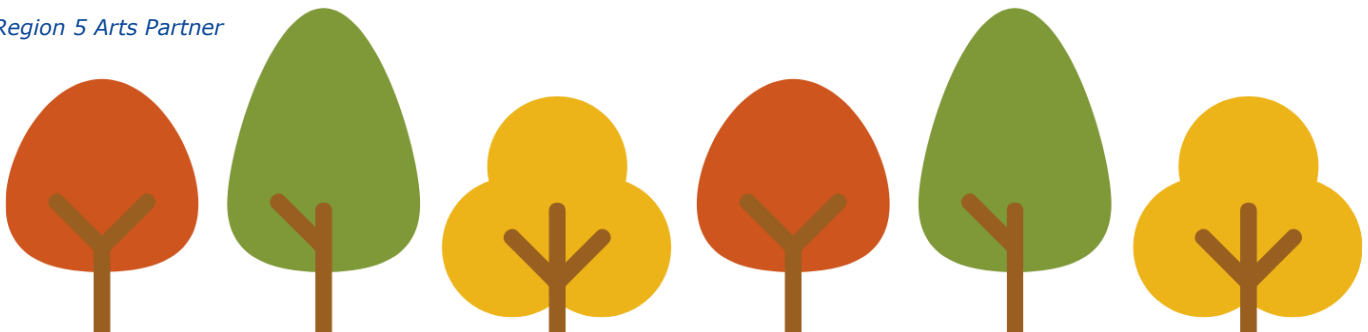
## CFRC AWARDS RECORD NUMBER OF GRANTS

The event took place on November 9<sup>th</sup> at the Towne Square Community Centre in Winchester. With the help of Towne Square Cinema, we were able to turn the Community Centre into our own red-carpet event, with donors and grantees being the stars.

# ANNUAL DINNER

## Education Fund

Board Member Joyce Hussman spoke about the Randolph County Fund for Education. This fund was established to help address the needs of educators and education in Randolph County. The Foundation has been challenging the community to give to this endowed fund to support educational endeavors now and for years to come. Grants will be made from this fund to assist with educational needs in our community. **CFRC is continuing to offer donors a \$1 for \$1 matching opportunity up to \$15,000.** After the Annual Dinner, we've just about reached our \$30,000 goal, but there is still opportunity for your gift to go twice as far!

## Indiana Landmarks

Missy Williams spoke about Promise Indiana Randolph County (a partnership between public schools and community leaders dedicated to helping Randolph County 3rd graders open CollegeChoice529 Savings Plans) and the annual history day that brings every third-grade student in the county to downtown Winchester to tour the historic courthouse and historical museum while interacting with first-person interpreters. This event led to Indiana Landmarks presenting their 2021 Sandi Servaas Memorial Award to the Community Foundation of Randolph County and Randolph County United. This award recognizes outstanding achievement in historic preservation, and it will be proudly displayed at the Randolph County Historical Museum.

## Winchester Foundation

The Community Foundation of Randolph County shares office space with the Winchester Foundation. This year marks the 75th Anniversary of the Winchester Foundation, which was founded on December 31, 1945 by Pierre F. Goodrich, son of Indiana Governor James P. Goodrich. The purpose of the organization is to “provide a means through which all interested persons might contribute and become part of the encouragement and stimulation of interest in and study of the arts, music, philosophy, religion, community thrift and savings, humanities, government, and political science.” Chris Talley, Chairman of Winchester Foundation’s Board, gave a speech detailing the history and mission of their organization, as well as its relationship with the Community Foundation of Randolph County. He closed by announcing that the Winchester Foundation, in honor of their 75 years, would be donating \$75,000 to the Community Foundation. The Community Foundation is incredibly grateful for this generous grant. “This generous grant from The Winchester Foundation will further the Community Foundation’s current initiatives and provide additional capacity for grantmaking practices in our county; we are incredibly grateful for this contribution,” said Lisa Jennings, Executive Director at the Community Foundation of Randolph County.

The National Endowment for the Humanities (NEH), Indiana Humanities' federal partner, announce a special initiative called A More Perfect Union. The purpose of the initiative is to advance civic education and to prepare to commemorate the 250th anniversary in 2026 of the signing of the Declaration of Independence. As part of the initiative, the NEH is providing state humanities councils with funding for programs that "deepen public understanding of the American experience—in all its complexities—and enhance the knowledge, skills, and capacities needed to sustain a thriving republic." 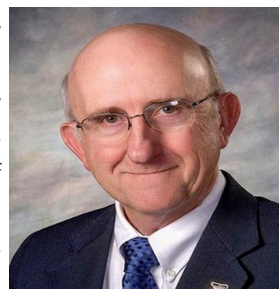

## RANDOLPH COUNTY HERO: DR. PHILIP HOWELL

Philip A. "Doc" Howell is certainly a HERO for many people and animals around the Randolph County area. From caring for farm livestock to treating the family pet, Doc Howell has been there for many years to serve his community. Dr. Howell has served on the Board of Directors of the American Angus Association, worked with kids at many a county fair (including his endless hours of education right here in Randolph County), and has served as a deacon and Sunday School teacher for junior high boys at Countryside Christian Church. He has been a leader, a mentor to young and old alike, and a friend and teacher to 4-H kids.



Dr. Howell attended Purdue University and graduated with a Doctor of Veterinary Medicine degree in 1973. After graduation, Phil worked in mixed animal practices in Cedar Grove, Wisconsin and Silver Lake, Indiana. To be closer to family, Phil purchased a practice in Winchester, Indiana in June 1979. Phil has served as a member and president of the county extension board and council and the Randolph County Beef Producers. He has been a member of the Agricultural Outreach Board of St. Vincent Randolph Hospital and the Randolph County Board of Health. In 1973 he married Judith Diane Siewert — a (retired) registered nurse and past president of the Indiana Angus Auxiliary. Phil and Judy own 50 cows, with the majority being registered Angus. They have hosted several open house/private-treaty sales and they have consigned cattle to several sales.

Phil is a member of the American Veterinary Medical Association, Indiana Veterinary Medical Association (where he completed two terms on the board), American Association of Bovine Practitioners, and the Indiana Bovine Interest Group. Phil has served as president of the Indiana Junior Angus Association (1969), IAA (2005), and the Southeastern Indiana Angus Association (2009). Since 2005 he has been on the IAA board and functioned as chairman of Indiana Angus News' communications committee. In 2006 he was chairman of the NJAS Daily Volunteers Committee and served as the veterinary service coordinator when the NJAS returned to Indianapolis in 2014. During his first term on the American Angus Association board, Phil served on the board of Angus Productions Inc. (API) for one year and the board of Angus Genetics Inc. (AGI) for two years. He served as chairman of the Data Force Subcommittee and was vice chairman of the Industry Relations Committee. If elected to a second term, he would pursue his original goal: the discovery and multiplication of superior Angus genetic material from small or large herds, increasing the value of the Angus registration paper, and encouraging the work of the Angus Foundation in funding scholarships and education.

Phil and Judy have been blessed with three children (all Purdue graduates) who have said the following about their father: "For 35+ years we have watched my dad follow his passion for animals and people. Many nights of my youth were spent in the truck, in a barn, or at the kitchen table working in one form or another. If someone called, my dad was there to answer. Pull a calf, trim feet, treat a sick dog, proofread an essay; my dad might do all of them in the span of one evening. Dinner time? That might be 6, or 8, or 9:30. The phone rings in the middle of the night? It was answered. And, the saying is true, behind every good man is a wife to support him. My mom was right there supporting him and us in all of our endeavors. (And, keeping dinner warm!)" | "Our dad taught us that we can learn from everyone we meet. Whether the example was good or bad, there was a lesson in all of our experiences. His goal - be a good example for everyone we meet. Even now that we have been out of 4-H for 20 years, Dad can still be found in the show ring as a ringman, helping check in animals and providing vet services when needed in the barns, and mentoring those who may not have the room for cattle at home, but want to be on the lead end of the show halter." | "Dad also taught us the importance of a relationship with God and a church community. He's served as an elder, helped in the nursery, and I never will forget the night he volunteered as the youth group had a lock-in and Bible read-a-thon. He served as an adult volunteer to listen as members of the youth group took turns to read the Bible. I happened to get the "begats". And, yes, I had to read all of those names and try to pronounce them as closely to accurate as possible. No skipping over names when Dad was listening! It may have been annoying then, but I appreciate that he taught us that shortcuts were not the way to get where we wanted. Success comes from hard work and persistence, not giving a half-hearted effort. I don't remember a time when either of my parents allowed us to submit work that was not our best effort. We may have been in the barn at midnight, or spread out across the kitchen table or living room, or even hemming a skirt at a family event, but whatever we worked on, it would be finished, and it would be presentable!"



## DAVID E. HYRE MEMORIAL SCHOLARSHIP

David "Dave" Hyre passed away on June 9, 2020 after a 3.5 year battle with kidney cancer in Destin, Florida at the age of 76. Dave was born on December 5, 1943 in Winchester, Indiana to Floyd and Pauline Hyre. He attended Winchester High School, Purdue University (Mechanical Engineering Bachelors), University of Michigan (Mechanical Engineering Masters), and Michigan State University (MBA). He was also part of the Chrysler Institute of Engineering (CIE Program). He worked at Chrysler for 35 years until he retired in 2001. Since retirement, he has been active in Resurrection Catholic Parish through the Men's Group (MORE), Ushering, and as a "money counter." He was also very active in the local Okaloosa County Habitat for Humanity where he co-managed building several houses and sponsored activities for college student volunteers. He was a volunteer usher at the Maddie Kelly Center for the Arts. He was an election poll volunteer and Special Deputy for the Okaloosa County. His favorite hobby was collecting watches; he was a member of the National

Association of Watch and Clock Collectors and participated in shows across the country. Dave loved his family, church, and community; always willing to help. He is survived by his daughters Maggie Abraham (Chris) and Kerry Meyers (Scott), his sister Jane Oler (John), and his 4 grandsons: Kenny, David, Andrew, and Zach.

Maggie and Kerry have established a scholarship fund in his honor. Recipients can be from any Randolph County high school. They must attend Purdue University (main campus or affiliate) and study a field of engineering. The scholarship will be renewable, as long as the recipient maintains at least a 2.0 GPA.

## FOUNDATION SPOTLIGHT: CATHY STEPHEN-MILLER



### What initially drew you to the Community Foundation?

*"I was initially involved in a small way with the Community Foundation when it first began—we were working on a Lilly Endowment CAPE Grant for the County, and I was the grant writer. I learned at that time what the Foundation did for the community. When my father passed away in 2005, he requested donations to a scholarship for students who had attended Willard Elementary when he volunteered there, which we set up at CFRC. When my husband, Kellie, became ill with cancer, and we knew he was not going to make it, we again turned to the Community Foundation to set up the Stephen Family Fund for Scholarships. When his friends wanted to do a golf outing in his memory for scholarships for athletes at all five Randolph County Schools, again the Community Foundation was the vehicle we chose. I am proud to say both the Stephen Family Fund and the Kellie Stephen Memorial Fund are both now endowed funds."*

### What committees have you been involved with, and why did you gravitate toward them?

*"I have served on various committees during my tenure with the Foundation Board. I started out on the grant committee to learn how our foundation could help other non-profits in our community. I worked on the Asset Development Committee where we developed the Randolph County Heroes Fund to give our community opportunities to honor people or groups either living or deceased. I have served on the local scholarship committee and served as a fill-in judge a couple of times for the Lilly Scholarship. Currently, I am chair of the Nominating Committee, which recruits new board members and nominates a slate of officers each year for consideration by the Board. Because of my history with grant writing, I volunteered to be on the Lilly GIFT VII Committee as well. This work has allowed us to join together with Randolph County United and Ball State University for Cultivating Community. My favorite, and the work I am most proud of in the Foundation, is the Promise Indiana of Randolph County. Five years ago, we wrote a grant and raised enough money to fund College Choice 529 accounts for every 3rd grade student in Randolph County with a \$25 donation. I hope to continue with Promise even after I leave the Board of the Foundation at the end of 2021."*

### Why do you continuously choose to donate your time?

*"I retired from Randolph Eastern School Corporation in 2010 and then started my own educational consulting business, which I ran until January of 2020. Education is my passion, and the Community Foundation has given me an opportunity to continue with that passion without holding down a full or part-time job. I volunteer for other things besides the Foundation, but this is certainly my largest time commitment. My parents raised me to always give back, and my in-laws Gerald and Patsy Stephen taught me to love Randolph County and showed me by example how rewarding community involvement and volunteerism can be. I hope I can follow in their shoes and as well my father's, who volunteered at Willard until after his 90th birthday! I have received so much from this community, and I want to give back in any way I can."*

### Is there anything else you would like to share about yourself or your experience?

*"I feel so blessed that my late husband, Kellie Stephen, drug this Muncie girl to Randolph County! I spent all of my educational career at three Randolph County Schools - Union, Randolph Central, and Randolph Eastern. Kellie also worked at Monroe Central. Our children, Shannon Hartley, Stephen Hartley, and Carrie Baldwin, all received wonderful educations in Randolph County and are quite successful in part due to that. After Kellie's death, I was astounded by the generosity of this community with their contributions to the funds honoring him and the support and outpouring of love our family received. I was also blessed nine years after Kellie's death to find a man who had lost his wife too early to cancer. Dr. Tom Miller, also a retired superintendent and educational consultant, has joined me here in Randolph County. We also have a home in Fishers. We both assumed we would have homes somewhere warm in the winters, but family is so important to us that the two homes in Indiana, close to some of our six children and 16 grandchildren, better fit the bill!"*
