## Scholarships Make a Difference

Each year, the Community Foundation grants over 80 scholarships to Randolph County seniors thanks to the 50+ scholarship funds held at CFRC. This year, the foundation was able to grant its largest amount in scholarships to date! The total amount awarded to high school seniors to further their educations was \$305,900. "I remember sitting on that stage and hearing my name called for scholarships, six years ago." stated, Scholarships and Community Development Officer, Autumn Dixon, CNP. "I remember how honored and motivated I felt, that there were people in our community who believed in my dreams of furthering my education, and now I get to be one small part in that with my role here at the foundation." she concluded.

Not only did the foundation reach its highest amount to date, it also was able to launch its newest initiative at Winchester Community High School's awards night. CFRC Board President, Tom Osborn, staff member, Autumn Dixon, and community members, Dane Starbuck and Pat Knasinski came together to work on a new project they titled, "scholarship enhancement". The Scholarship Enhancement Project came from the idea that the recipients of these scholarships are often not connected with the individuals in which the scholarships honor or memorialize. 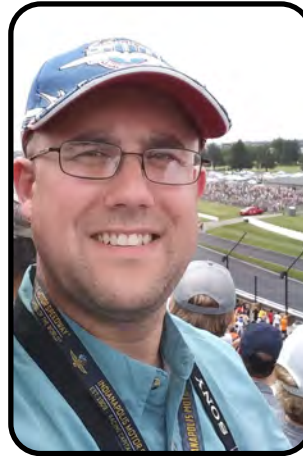
# New Faces at the Foundation

## *Marla Threewits*



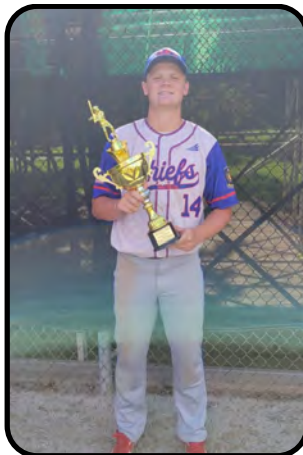

# *Faces at the Foundation Spotlight*

## *Kurt Prescott*



Born and raised in Randolph County, Kurt Prescott grew up on his family's farm just outside of Saratoga with his parents, John and Arta Prescott, and two brothers, Jeff and Troy. Entering high school, he believed he wanted to enter the field of accounting but he decided to take agriculture classes since he was living and helping on the farm. Through ag classes and the Future Farmers of America (FFA), Kurt was introduced to monthly meetings, leadership, and public speaking. After high school he enrolled at IU East. However, by the time he earned an Associate Degree in Accounting, Kurt realized that farming was what he really wanted to do, so after graduating he began his pursuit of becoming a full-time farmer.

As his father had let him rent land while in high school as well as having him work on the family farm to help with college expenses, Kurt had a good start when, in November 1983, he married Sherry White and they moved to a farm east of Saratoga that Sherry's great-grandparents had owned and lived on until their passing. As fate would have it, that farm had been rented by Kurt's family and, upon Sherry's grandparents passing, Kurt's father purchased the farm. So Kurt and Sherry started their married life together in the same house where Sherry used to visit her great-grandparents.

Kurt and Sherry have two children: Megan (husband Justin, children Logan and Aiden) and Jordan (wife Brittany, children Kayleigh, Crosby, and Hayes). Today, Kurt farms with his son Jordan, and Jordan and his family now live in the house that Kurt & Sherry lived in, Jordan's great-great-grandparent's former home.

Community involvement has always been important to Kurt. Currently, Kurt serves on the Randolph County Farm Bureau Board, Saratoga Cemetery Board, Wesley Methodist Church Trustee, and Community Foundation of Randolph County. He also has previously served on the Saratoga Volunteer Fire Department and was on the school board for Randolph Eastern for 16 years.

A board member of the Community Foundation since 2015, he currently serves on the finance committee. He has also served as president and treasurer of the board. Kurt likes the idea that the Foundation, through gracious gifts of many, is able to help better the lives of Randolph County residents through grants and scholarships that benefit many. # Randolph County Heroes

This effort is the result of a Community Foundation program that helps recognize such people, while also raising money to help others. The program started in 2015, and since that date, this nomination will make the 29th Randolph County Hero. For \$1,000 anyone can nominate a person (living or deceased), business, or community organization for the designation of a Randolph County Hero. The money goes into our unrestricted fund, which the foundation uses to do and support great things in Randolph County for years to come. Those designated as Randolph County Heroes will have their names on a plaque at the Foundation office and will be featured in media outlets. The Randolph County Heroes Fund is a wonderful way to remember someone who has passed and a great way to honor those currently working to make Randolph County a better place to live. .



*Dixie Osting*

In the fall of 1986, Dixie started Dixie's Dance Studio as a little hobby, never dreaming how that decision would end up igniting community in Winchester for 32 years. She and her parents made the dance studio a second family for many participants. Dixie has had a long-lasting effect on thousands of students and their families as she instilled life skills, which ensured her students have been able to prepare and present themselves positively in all situations and to become successes in anything they attempt. Dixie's students knew the studio was their home away from home.

When she opened the dance studio, Dixie could not have anticipated that it would grow into one of the region's foremost starting points for learning as her students learned not only dance routines, but skills that would carry over through a lifetime. Anyone who joined her studio became part of a close-knit family who would embrace mantras such as "Attitude is Everything" and "Everybody Loves Everybody." Dixie was a shining star in all of Randolph County. She attended Greensburg Community High School and was an unbelievable dance teacher who, started studios in Greensburg, Westport, Columbus, Logansport, Brookston, Delphi, and Winchester.

Dixie married the love of her life, Dallas Osting, on August 4th, 1968. They enjoyed 53 years of marital bliss and raised their four children – J.W., Wendi, Shane and their youngest, Kyle. Dixie and Dallas Osting spent their time together at the many basketball games and track meets that Dallas coached at Winchester Community High School. Along the way, Dixie became a pillar in the community and became a magnet for developing friendships, often after only a brief encounter. "She never met a stranger," her husband Dallas says. "She was always making new friends, even though she just met someone." Dixie Osting was a strong, confident woman who excelled as a mentor, friend, mother, grandmother, and spouse, and perhaps most of all, as an inspiration to the many thousands of area students who joined her dance family. "I feel very lucky because we had a special relationship that few couples have."

Since taking over Dixie's Dance Studio in 2007, Kyle has continued with his mother's vision, creating INSPIRE at DDS while adding more creative routines and entering more competitions. With fewer responsibilities at the dance studio, Dixie had more time to spend with her grandchildren and support her children in their careers. Over the last several years, Dallas says, Dixie "took cultivating her grandchildren very seriously" and attended as many of their activities as she possibly could. Her dance studio was the vessel for Dixie Osting's message of focusing on the bright side of life, believing in ourselves, putting our best foot forward, and reaching for the stars. Dixie's gallant fight to beat her cancer was another way she showed determination and grit to our Winchester community. Dixie and Dallas have served as inspirations to many, and through her life of service to others, Dixie Osting is a Randolph County Hero.

## Cultivating Community - Action Group Highlights

### Quality of Life

- The committee created a parks brochure that promotes all of Randolph County's parks
- Created a mascot for Randolph County parks, Randy Raccoon
- Park signs have been designed and are in the process of being created: every park will have at least one sign (featuring Randy Raccoon)



### Trails

- The committee is working to obtain MOAs from property owners along the proposed trail from Cardinal Greenway to Modoc, IN

### Waterways

- The Conservation Law Center tried to help the committee deem the White River navigable in Randolph County, but legally there are no feasible options as of now
- The committee will be bringing an Indiana Humanities Unearthed Speaker to Randolph County to talk about waterways later this year

### Housing

- Based on the Housing Committee's recommendation, the County entered into an agreement with the Housing Resource Hub.

### Education

- The committee's internship program is entering its second year, with 4 local businesses participating this year.
- The next project will be producing informative videos of various career opportunities for youth in our county. This involves partnerships with local businesses, schools, and Kiss TV

### Childcare Coalition

- The coalition continues to focus on facilitating training opportunities for childcare facilities.

### Business Attraction & Retention

- Hosts quarterly Coffee & Conversations to present on different professional and personal growth topics
- A new project for 2023 is to host business retention interviews with local businesses

### Technology

- The committee was initially planning to place a tower, but has chosen not to as it is not cost-effective for the county
- The committee has been named the Broadband Ready point of contact for Randolph County



The Randolph County Forum of Funders has officially started meeting, and is now up to 10 voting members! The Forum of Funders is a forum created to support the cultivating communities initiatives by granting to the action groups.

## Welcoming Indiana's Next Generation (WINGS) Fund

Did you know that Winchester's Goodrich Park will soon be home to a splash pad?

When the splash pad is finished, it will not only mark the arrival of a new place for summer fun but also the first project completed with funds distributed through the Welcoming Indiana's Next Generation (WINGS) Fund.



Established July 31, 2018, the WINGS Fund was designed to support projects and charitable causes "to enhance the quality of life in the Winchester, Indiana community." The impetus behind the creation of the Fund was a decision of the Indiana Housing and Community Development Authority (IHCDA) to assist with the retirement of debt related to the IHCDA-loan-supported Winchester facility housing Volunteers of America of Indiana's "Fresh Start Program."

Instead of payments to IHCDA, the City of Winchester, Volunteers of America Ohio & Indiana, the Community Foundation, and IHCDA have agreements that direct annual contributions to the WINGS Fund in exchange for debt forgiveness on the IHCDA loan. Following the last of the scheduled contributions, the WINGS Fund will have an endowed balance of nearly \$300,000, which will provide an annual source of revenue "to enhance the quality of life in the Winchester, Indiana community" through various projects.

"As a service provider in Randolph County dedicated to maternal and infant health and healthy communities, Volunteers of America Ohio & Indiana is proud to deepen its local commitment through Welcoming Indiana's Next Generation (WINGS) Fund investments to help ensure all individuals and the community thrive today and well into the future," stated John R. von Arx III, President & CEO of Volunteers of America Ohio & Indiana.

So, when you hear the laughter and shouts of excitement rising from children enjoying the Goodrich Park Splash Pad in years to come, remember that those signs of a care-free childhood experience were delivered, in part, by WINGS -- the Welcoming Indiana's Next Generation Fund.
