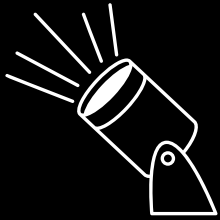
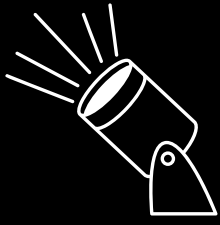

Thanks to a generous estate gift from Frances, the Frances I. Woods Scholarship will be awarded to a graduating senior at each of the five Randolph County high schools each year. To qualify for this multi-year scholarship, the recipients must have demonstrated good character as well as good citizenship, participated in extracurricular activities or community activities, and graduated with a 3.5 GPA or higher.

ACORN FUNDS

MISSION STATEMENT :

The Community Foundation of Randolph County, Inc. seeks to bring people and resources together to strengthen the quality of life, both now and in the future, for the residents of Randolph County.

PLAN "THEN" NOW

Your Acorn Fund will need to reach a minimum of \$10,000 within five years before it can become an endowed grant-making fund within the Community Foundation of Randolph County. Your contributions, multiplied by good investment, will reach these goals in a surprisingly short period of time.

PLANTING A FUND

Thanks to an ingenious Community Foundation of Randolph County giving plan, the rest of us now can build up charitable endowment funds that support annual charitable grants and have extraordinary long-term impacts.

An Acorn Fund helps you harness the power of financial markets to multiply the value of your contributions over time. All you have to do is make regular contributions and take a charitable tax deduction for them. Investing even small amounts regularly will build an endowment that grows dramatically.

When your Acorn Fund "matures" it becomes a permanent charitable fund within the Community Foundation of Randolph County and makes annual grants for the purposes you specify.

And here's the best part: it never stops! Every year, generation after generation, the causes you care about will receive support from your fund – the Acorn you plant today!

When setting your endowment goal, you will need to consider:

- The purpose of your fund
- The number and amount of grants you wish to make each year
- How quickly you want to meet your goal, and Your own financial situation.

Decide on contributions. You can invest as little as \$500 per quarter or \$2,000 per year. The more you give, the faster you will reach your goal and the larger your annual tax deduction.

You can add to your fund at any time, even after it has become a Community Foundation of Randolph County endowed fund and has started making grants.

The Community Foundation of Randolph County will place your Acorn Fund contributions in a non-risk bearing account where it will earn interest.

Nominating a Hero

With a minimum gift of \$1,000, anyone can nominate a person (living or deceased), business, or community organization for the designation of a Randolph County Hero. The money goes into an unrestricted fund, which the Community Foundation uses to do and support great things in Randolph County for years to come. Master Trails Plan

GIFT VIII PLANNING GRANT: TRAILS MASTER PLAN



THE MASTER PLAN IS COMPLETE!

Thank you to all who have contributed to this project.

A trails master plan is a report that provides recommendations for trail routes connecting points of interest through the county. Within the report, you'll find sections that include the data gathered during inventory and analysis, maps of the proposed trails, cost estimates, funding, and implementation strategies. The full report can be found on our website (www.randolphcountyfoundation.org/randolph-county-trails-master-plan/).

This is a community driven project, and a trail committee was formed as a county-wide trail network was identified as an important quality of life issue in Randolph County.

"A future, county-wide trail network would connect Randolph County's numerous tourism and recreation destinations. But rather than use one or more of the vacant or abandoned rail corridors, community leaders offer that enhancements along some of the county's existing road network as a viable option for establishing a county-wide trail network, over time."

In 2024, The Community Foundation of Randolph County received a \$50,000 planning grant as part of the eighth phase of Lilly Endowment Inc.'s initiative, Giving Indiana Funds for Tomorrow (GIFT VIII). With the grant, the Community Foundation partnered with engineering firm Butler Fairman & Seufert (BF&S) to develop a Randolph County Trails Master Plan. This is building upon the efforts of the Trails Committee formed through the Cultivating Community initiatives.

The process of creating the Trails Master Plan included an initial meeting, data collection on existing and planned projects, stakeholder meetings, an online public survey, a public open house and workshop, and a final plan presentation. The creation of the Trails Master Plan will support various entities within the county as they seek additional funding to enhance the network of trails available to residents and visitors of Randolph County.

"This GIFT VIII planning grant will allow us to continue the momentum that has been created by the Trails Committee established through the Cultivating Community initiative, which is a partnership between RCU, the Community Foundation, and Indiana Communities Institute," said Lisa Jennings, Executive Director of the Community Foundation of Randolph County.

Rebuilding Randolph



The evening of March 14, 2024, a tornado tore through our community, and the following morning the Community Foundation received a call from Mayor Bob McCoy with a request. There were people that wanted to help and donate, and we were leaned on to assist with coordinating relief efforts and donations. At that time, we had no idea the gravity of what we were wading into, but willing to help, we stepped in with the creation of the Randolph County Relief Fund.

A week later, a meeting to introduce Randolph County to long-term recovery efforts took place in the Commissioner's Room. For many of us, we learned for the first time about long-term disaster recovery. It was a daunting task. But volunteers stepped up, roles were assigned, and the work began.

What did that mean for us at the Community Foundation? For us, it was a heartbreaking and moving experience. We saw so much hurt and devastation in our county, while also seeing many donations come pouring in. People in our community giving what they could; people living outside our community that have roots in Randolph County pouring back into the community that brought them up; strangers unconnected to our community at all sending anonymous donations just wanting to help. We at the Foundation saw the hearts and generosity of so many people. If you haven't heard it from us already, this is a sincere "thank you" to all of you that have given.

From individuals, families, businesses, and grant opportunities, the Randolph County Relief Fund has raised over \$500,000. These funds are being and will continue to be used to assist those uninsured and underinsured that were impacted by the tornado. What it looks like now is an effort you may have seen called Rebuilding Randolph. A Long-Term Recovery Team of volunteers, covering a vast arena of needs, stepped up shortly after the disaster and continues to work.

Here's a brief explanation of how the process works: those impacted were encouraged to either call the hotline or send a message on the Rebuilding Randolph website notifying they needed assistance. A case manager, one of the volunteers, is then assigned to their case, walking through the process with them from beginning to end. Case managers work with them, identifying the needs of the individual or family, determining what will get covered by insurance and what will not, and eventually identifying needs that are unmet. These unmet needs are where the donations to the Randolph County Relief Fund come in, filling the gap and assisting in these areas.

While significant progress has been made, the road to recovery is still long. Insurance companies for some cases are dragging their feet, leaving the long-term recovery team unclear of what the unmet needs will be. Despite being denied FEMA funding, the resilience and strength of our community have continued to shine through in these challenging times. We have been deeply humbled by the outpouring of support from across the county, state, and country, and by the countless volunteers in the immediate aftermath and in the months that followed. As we continue forward in these efforts, let's remember the power of compassion and the importance of community. By working together, we can overcome these hardships and emerge stronger than ever.
